Speakers & Topics

Ruth Calderwood - City of London Corporation

City of London's AQ Strategy & PM_{2.5} source apportionment

Ruth Calderwood is the Air Quality Manager at the City of London Corporation. The organisation provides local government services for the Square Mile at the heart of London. She is responsible for developing and implementing air quality policy and has worked in local government air quality management for over 20 years.





Louisa Kramer - Ricardo

Working to achieve DEFRA PM_{2.5} targets for local authorities

Louisa Kramer is a principal air quality consultant at Ricardo, specialising in analytical techniques, monitoring and data analysis of trace gases and particulate matter. Louisa has experience in managing and reporting on measurements from the UK AURN network and locally run monitoring sites. She is also experienced in analysing data from lower cost air quality sensor units.

Tim Dexter - Asthma + Lung UK

Working with local authorities to improve indoor air quality

Tim Dexter is the Clean Air Policy and Campaigns Lead at Asthma + Lung UK. He oversees the charities influencing work around air pollution, ensuring it is high on the political agenda and leads on supporting our networkers of campaigners fighting for cleaner air in cities across the UK.

Air quality benefits of climate plans in relation to PM_{2.5} targets
